We're facing the COVID-19 pandemic together

Given the fast pace of change we have had to deal with during this worldwide pandemic crisis, we decided to dramatically change the format of this edition of OE News in order to pass along current and relevant information in a timely way.

With situations literally changing by the hour, we have structured this edition to contain information that will continue to be a quick reference guide to cover situations tied to employment issues, safe work practices, and all the government resources currently available to assist our membership through the weeks and months ahead.

We were looking forward to Premier John Horgan attending our General Membership Meeting (GMM) which was to have taken place on March 21, the Premier was to speak to our members about upcoming infrastructure work and all of the positive changes that we have accomplished over the last few years. It was approximately a week before the GMM, the health crisis in British Columbia started to escalate in a dramatic way and everything started to shut down, so it was disappointing to say the least. I have spoken with his office, and he will try to reschedule addressing our membership when we come out the other side of the current pandemic.

IUOE General President James T. Callahan was honoured to be named the "Grand Marshal" in the New York City St. Patrick's Day Parade this year which was to be held on March 17th. On March 12th the pandemic was taking hold in New York City and ultimately, the parade was postponed. This is the first time in 250 years it didn't go on as scheduled as it had always done despite the wars, weather, Spanish Flu, Asian Flu, SARS and all of the other catastrophic events during that time.

The restricted travel and trade activity between borders and the overall economic impact to our society is something that we are just going to have to work through over the weeks and months ahead. The important thing now is to work together and support all of the necessary measures that will keep you, your family and community safe and healthy for the long term.

This is a defining moment, and I believe British Columbia has handled this situation very well in comparison to many other parts of the world. The exceptions to this of course are the folks that have been unnecessarily hoarding, or trying to make additional profit from goods we all need (toilet paper – really?). We are certainly fortunate to have the strong leadership necessary in Canada to guide us through these uncertain times.

As far as the Local Union is concerned, there is no manual or playbook for dealing with any of these issues. It is the equivalent of managing a provincial strike across all sectors – on steroids – while ensuring that our member's health and safety is at the forefront of every decision we need to make.

Local 115 staff have pulled together very well, having to react to unexpected job shutdowns, quarantines, and all of the COVID-19 concerns that come into play at every location where our members work across the Province.

My message has been clear - we need to stay calm, focused and diligent as we deal with this crisis.

While things will no doubt be different forever, we will be stronger and better prepared because of working through this event.

Local 115 is in our 89th year of service to our membership – we have been through a lot, and 12 months from now, Operating Engineers are going to look back and be proud of their contributions in leading the return to a "new" normal.

Meanwhile, stay safe and I encourage everyone to sign up for email updates, and check our website frequently at iuoe115.ca regularly for timely information.

Brian Cochrane, Walter Canta and Nav Malhotra: Expanding infrastructure construction jobs can help restart B.C. economy

B.C.'s workers and businesses are suffering badly as our provincial economy takes what could be the biggest hit since the Great Depression because of COVID-19. But there is still great hope for the future.

No matter how long this deadly virus troubles our province and the world, ultimately we will all come out of isolation — and need to get our economy going again to repair the enormous damage done.

Some sectors of our economy are now devastated, with little hope of an early recovery. Tourism, hospitality, entertainment and retail are facing most of the 500,000 job losses predicted by the Business Council of B.C.

But one sector remains mostly intact and — with appropriate health and safety measures, rigorously followed — can help lead the province out of financial trouble: the construction industry.

B.C. now needs to plan for the largest infrastructure construction program ever seen to stimulate our battered economy by creating new jobs, investment and tax revenue.

But as union leaders representing thousands of construction workers, the safety of our members is the first priority.

That is why we have designed and submitted to WorkSafeBC this week a comprehensive proposal for appropriate and effective health rules to maintain the safest possible construction worksites, which are very different from all others.

Construction workers can keep making an enormous contribution to the province if they can work safely — especially building hospitals and health-care facilities — with construction revenue and taxes helping ensure our economy doesn't contract even more disastrously than the predicted decline of seven to 12 per cent, or possibly greater.

What's more, when this novel coronavirus has been neutralized and, hopefully, a vaccine developed, B.C.'s economy will still be need of urgent care.

That is where construction infrastructure projects can come to the rescue.

The provincial, federal and municipal governments have wisely already committed significant funding for B.C. projects — such as the Broadway SkyTrain extension, the Pattullo Bridge replacement, and the Kicking Horse Canyon highway expansion — where our members are already working.

But in the face of the economic destruction this unprecedented health crisis has caused, it's time for all three levels of government to truly think big and stimulate our economy with the biggest infrastructure construction program we have ever seen.

U.S. President Franklin D. Roosevelt helped lead his country out of the 1930s Depression with the New Deal, the most significant government infrastructure building program the world had seen, inspiring other countries to do the same.

We should be no less ambitious today if we want to overcome the economic adversity facing us for years to come.

So let's keep building the Broadway SkyTrain extension but go well past Arbutus Street, as currently planned, all the way to the University of B.C. And let's shorten the time frame — building the SkyTrain line not just longer but faster, hiring extra workers to get it done.

B.C. needs more hospitals, as planned in Surrey, more schools, more replacements for transportation bottlenecks such as the Massey Tunnel, more rapid transit to create a greener, sustainable economy, more energy-efficient buildings to reduce greenhouse gases and save on costs.

And if Community Benefit Agreements are used as they have been on several important projects, they will ensure that local, Indigenous, disabled and women workers get significant job opportunities on these projects, including apprenticeships and training that will last a career.

All these projects will help the province enormously in several ways:

First, by getting B.C. back to work, with construction workers spending their wages to support local businesses crushed by COVID-19.

Second, all of these infrastructure projects will create new jobs and new career opportunities for thousands of British Columbians put out of work.

Third, these are definitely not "make work" projects — they will create much-needed infrastructure that will serve our province for decades to come.

And, lastly, these projects can be financed with record low interest rates that minimize debt servicing costs, making it possible to amortize larger expenditures over a long period of time.

COVID-19 may have kicked the hell out of B.C., but we can use this crisis as a golden opportunity to make our province a much better place in the long run.

Construction workers, unions and the industry are optimistic about B.C.'s future and standing by to help. Let's get to work.

	The COVID-19 (coronavirus) pandemic is impacting employment for an unprecedented number of people across the country. Below is a summary of available supports you may find helpful.
EI-Qualifying Layoff	 Apply for El as normal if you are laid-off for non-medical reasons Need 700 hours work in past year Record of Employment (ROE) required Pays up to \$573/week First 4 months, you will receive Canadian Emergency Response Benefit (CERB) If you are already receiving El, benefits continue as before If you are receiving El and benefits end before Oct 3, you can apply for CERB.

The Districts: an overview

As we go through these unprecedented times, the IUOE Local 115 team has been continuing to work and advocating around the clock for all of our brothers and sisters not only in the local but for all trades members across the province.

We have been communicating as much as possible over the past month keeping everyone informed with relevant and timely documents, procedures and references. We have revamped our website and have set up our landing page as a hot button on COVID-19 updates which takes you to a separate page specifically set up for this pandemic.

Around the province we have been receiving updates and working with our members and signatory companies that are relevant to our operations and members, making sure we have the current pulse of the issues facing our membership and staff. This is so that any discussions internally and with contractors, not to mention with Government, WorkSafeBC, and others, includes timely and accurate information.

At time of print here is just a small snapshot of what has been happening throughout our districts.

We have had shutdowns, closures, slowdowns and layoffs occur throughout the province. Kemano project is being shut down with the exception of keeping the lights on and the roads clear. We are starting to have our members that are affected from this shutdown, booking into dispatch and a few have already been dispatched back out to work. IHE Winfield has extended their closure to April 20th. Trimac / H.M. Trimble and Sons (1983) Ltd. Prince George mechanic's shop has now closed. TECK is currently on a 16 day slow down with a 50% reduction of workers at site, with discussions on extending the slow down indefinitely after the 16 days.

While some companies are slowing down or shutting down, others such as Duchek Bulldozing, Greenbelt Excavating Ltd. and Delta Aggregates Ltd. are all business as usual. Some like Selkirk Paving Ltd. are ramping up in April.

Grievance meetings, bargaining and ratifications are continuing to move forward as normal, however how we communicate and meet has changed. Our Business Representatives are video and audio conferencing to ensure that our representation and advocacy for our members doesn't waver. A mail-out of ratification documents is currently being prepared for Roadbuilding (Emil Anderson Construction (B.C.) Ltd. (EAC) and BA Dawson Blacktop Ltd.).

While this pandemic is hitting hard across the world and making thousands quite sick, we are fortunate that our members have not been impacted at this time. At time of publication we know of several members across the province in self-isolation mainly due to travelling back from vacation, cold or flus, and some with compromised immune systems. At the time of publication we know of only one member that has tested positive and is recovering fine.

Our next publication will have more detailed district reports as you are used to. In the meantime, if you have any questions please don't hesitate to contact your Business Representative in your area to get the latest information.

Avoid the scams during the pandemic

Online frauds and scammers are taking advantage of the pandemic situation and increasing their attacks through email, text messages, voice-mails and phone-calls.

However there are ways to protect yourself:

• Don't reveal sensitive personal information in an unsolicited email or text message.

• Regularly monitor your bank and credit card statements for any unusual activity.

• Shred personal documents before recycling them or throwing them in the garbage.

• If you lose your bank-issued card, phone the bank or service immediately.

• Regularly change your PIN numbers, and keep them to yourself.

Another way to help protect yourself is to be aware of the scams hackers and other frauds use to rip people off.

Often they'll pretend to be from a utility service or a government department. They will often try to threaten you with legal action for not paying an outstanding bill.

Some will pretend to be raising money for a well-known

charity. They may even offer you a gift in return for a donation.

During this pandemic, some are known to be claiming they're from a medical service and are calling victims, falsely telling them they tested positive for COVID-19.

Some will even send you an email pretending to be someone you know.

All of them usually have one thing in common, they'll ask for your personal and financial details – don't give it to them. Instead if you think you've been the target of a scam follow these three steps:

• Contact your local police force and file a report.

• Contact your bank/financial institution and credit card company.

• Contact the two national credit bureaus and place a fraud alert on your credit reports.

IUOE* Bursaries and Scholarships

Education is important to our members and their children, which is why a number of scholarships and bursaries are available to Union members and their families. Some of the awards that are available:

IUOE Canadian Conference Bursary

Awarded annually to a dependent of a member of a Canadian local of the Operating Engineers. Bursary Amount: Ten bursaries of \$750 each. Two of these are allotted to British Columbia.

Criteria: The bursary recipient must be entering their first or subsequent year of a full-time course of study (at least 2 years in length) leading to a diploma, certificate or degree from any recognized public Canadian college or university.

Applications Deadline: August 1.

BC Building Trades Fred Randall Bursary

The British Columbia Building Trades established two bursaries in memory of the late Fred Randall, who was an MLA and Business Manager of Operating Engineers Local 115.

Bursary Amount: \$500 each to two successful candidates. *Criteria:* Applicants must be a member of a Building Trades union in good standing, be enrolled in a unionrecognized trades training program, and submit a 250word essay on the topic of "Commitment to Trade Union Principles".

Applications Deadline: June 30

M.L. Parr Award
